- OPTIONAL USE OF PERSONAL LOCKER (Men or Women Locker Room Available)

- PAYMENT IN FULL WITH A 5% DISCOUNT IF PAID BEFORE DECEMBER 15TH 2011
- NO PRORATED PAYMENTS AFTER JANUARY 1ST 2012
