**RULES REGARDING ANNUAL GOLF PLANS**

- IHGC is pleased to offer several Annual Golf Plans that will provide the frequent golfer flexibility in their golfing habits through our value-add program that will make their golf experience more enjoyable while providing the Plan Holder a fixed golfing budget.
- Individual (7 Day Annual), Couple (7 Day Couple Annual), Senior (5 Day Annual) and Senior Couple (5 Day Couple Annual) Annual Golf Plans Rates include: Green Fees – choice of use of IHGC Cart or Use of Personal Cart – 14 day advance Tee Time Bookings - 15% Reduction in the Golf Shop on all regular priced merchandise in stock (excludes Hard Goods and Special Orders) – Unlimited use of Range Privileges – 15% Reduction on purchases made at The Grill (excludes Bev Cart) - Convenience of Golf Plan Holder Charge Account Number (Account Holder Option) – Sales Tax will be added to all fees at time of signing.
- New offering as of 2025 all Annual Plan Holder will also receive a 20% discount on reservations in the Simulator Bay. Bays can be reserved for 1-hour blocks. See golf Shop for reservations.
- Individual (7 Day Annual), Senior (5 Day Annual) and is intended for a single person. 5 Day Annual Plan does have an age requirement of 55 or older and play is limited to Monday – Friday only.
- Couple (7 Day Couple Annual) Golf Plan and Senior Couple (5 Day Couple Annual) Golf Plan is intended for two persons that are in a relationship and reside in the same household. Is only Available for those that were grandfathered in. This Plan is no longer available for New Pass Holders
- Annual Golf Plans are only sold as a one-year commitment effective January 1<sup>st</sup> through December 31<sup>st</sup>. Junior Plan are sold as 12-month plan based on Start Date of signing.
- All Annual Golf Plan fees are subject to sales tax.
- Annual Golf Plans are not transferable nor shall be suspended by the Plan Holder for any reason. IHGC reserves the right to terminate this agreement for failure to adhere to the agreement and/or the normal and customary rules of IHGC without refund to the Plan Holder.
- Monthly Charge Account allows the primary plan holder and his/her designees the convenience of purchasing items in the Golf-Shop and Grill and charging them to the Primary Plan Holder Account Number (Account Number to be assigned after agreement is signed). All Plan Account statements will be mailed out during the first week of the month for the previous monthly charges. **Payment for Plan Holder Account is expected to be paid in full by the 20<sup>th</sup> of each month. In the event payment is not made in full, within the allotted time frame, Plan Holder Charge privileges will be suspended along with all other plan privileges. In addition, a late fee of \$25 will be assessed to your account.**
- Golf Plan Holders, with Plan Holder Charge Accounts, can expect to receive a monthly statement, of the previous month's charges during a given billing cycle that are accurate and timely.

- We are offering the Plan Holder Charge Account Number as a convenience for our Annual Golf Plan Holders. We understand that on occasion, a mistake could occur either on behalf of the Plan Holder or IHGC. In the event there is a disputed charge, the Primary Plan Holder must contact the business office for resolution. We are more than willing to assist in any manner that will be mutually acceptable to both parties.
- **Golf Plan Holder must keep their Plan Number Charge Account current and in good standing each month. In the event a Plan Holder Account becomes delinquent, Full Plan Holder Playing and Charge Privileges will be suspended until such time account is paid in full and returned to good standing. In the event of a suspension, the original plan expiration date will remain in affect.**
- The Plan Holder Account Number is a unique number assigned to each Primary Plan Holder. This number should be treated as any other personal financial information by the Plan Holder and his/her authorized users. IHGC will take care to get to know each of our Plan Holders and their authorized users; however, IHGC will bear no responsibility for fraudulent charges on any Plan Holder Account Statements.
- **Golf Plan Holder must register in the golf shop prior to each play.**
- Golf Plan Holder may call or register on-line Tee Times a maximum of Fourteen days in advance. Other Guests may schedule Tee Times Seven Days in advance.
- Annual Golf Plan Privileges do not include entry fees to special events coordinated by IHGC.
- Annual Plan Holder participating in tournaments or privately sponsored events will be responsible for all entry fees pertaining to the event.
- IHGC reserves the right to host outings and privately sponsored events where the facility and grounds may be booked exclusively for these events. In these cases, the Annual Golf Plan Holder must realize that tee times and/or the facility may not always be available for their use.
- It is our intent to maintain a certain level of quality on the course. As such, certain rules apply and are subject to change based on the daily conditions related to weather or other needs. Specific Rules of play and course conditions will be posted daily. These rules must be followed by all guests for the benefit of all guests and course maintenance. Failure to follow course rules may result in ejecting guests from the course. Repeat offenders will be suspended from future play on the property. This applies to all guests, not just Annual Plan Holders.
- **IHGC does not allow Outside Beverages and Food Products on the course. All Food and Beverages must be purchased from IHGC Grill or Beverage Carts. Personal Coolers are not allowed.**
